**Recruitment Tips**

- Approach the patient/family early
- Early screening and engagement of the clinical team is key
- Consent is a process:
 - Educate, listen, and discuss
 - Establish rapport with patient and family
 - Communicate with statin prescriber early
 - Be non-committal
 - Sign consent form

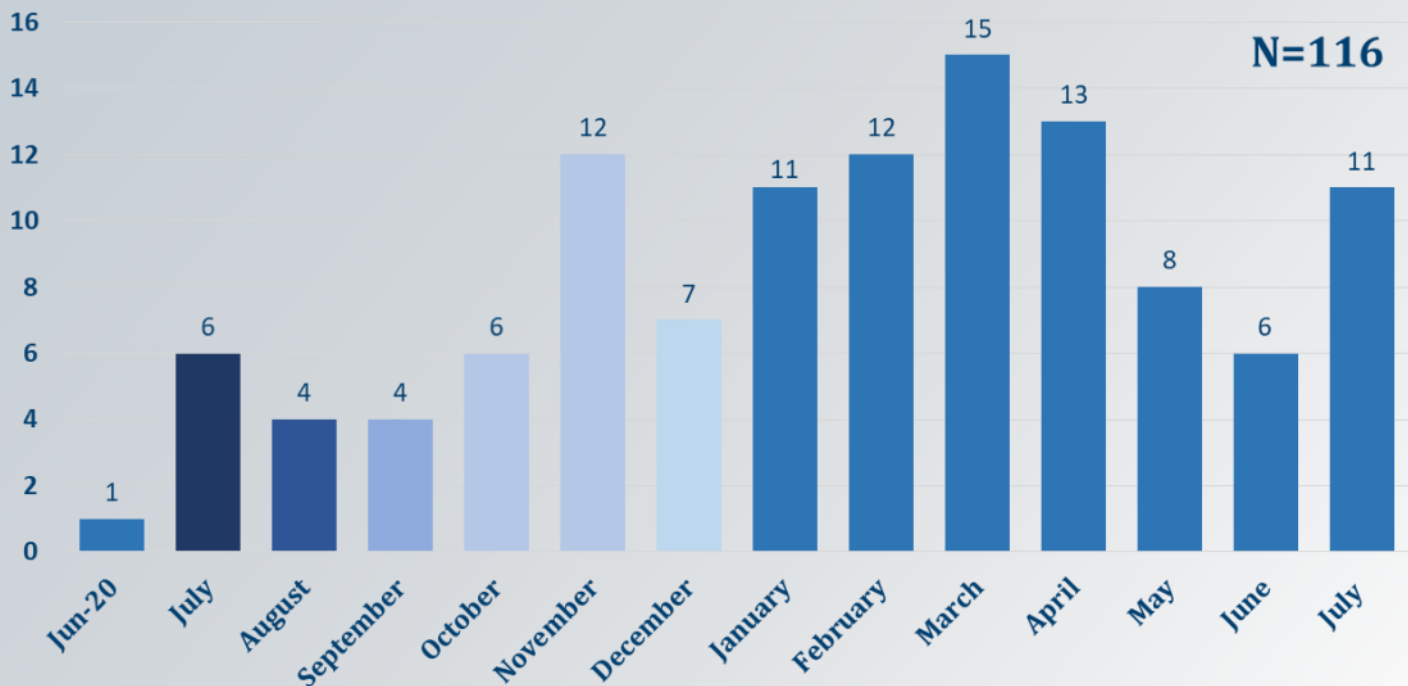

Reminders

DOA Updates

Please remember to update your site DOA whenever there is a new study team member or a change in current site personnel. Make sure that this is always up to date. You can make changes by selecting the User Management tab on WebDCU. In order to add a new study personnel click on the Study Team Member Request tab, and to edit an existing team member click on DOA Submission tab to change their information and permissions.



Other Contact Information

All sites must update personnel contact information in WebDCU to include telephone numbers, especially that of the primary coordinator, as well as the trial communication plan. All emails and phone numbers must be up to date. If the correspondence involves regulatory information, those on the DOA will be included as RDCs. Primary study coordinators are responsible for sending trial information to the right team members.

Reminders

Hospice Care

If a patient is transferred to hospice care and the subject/caregiver/LAR has requested that no further follow up be conducted, the site will need to fill out an End of Study form. Under the explanation section, please enter the following **exact** wording:

“Transitioned to hospice care, requested no further follow-up.”

Restarting Statin after Randomization

If a subject’s statin is stopped after admission and they get randomized to continuation of statin, make sure that the statin is restarted **immediately!** Do not wait for discharge.
