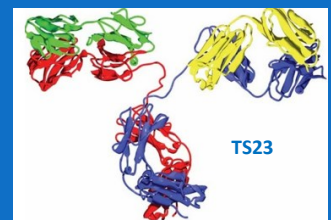

Screen Failure Log

Screening is very important to SISTER as we look at the trends every week during our Operations Call.

- ⇒ If the mismatch value is infinite, leave the value blank and indicate in the general comments that the mismatch was infinite. Do not enter "0" or "999".
- ⇒ Please make sure that you are using the changes from Protocol v4 for screening and marking it appropriately in the screen failure log.
- ⇒ The screen failure log should be completed in "real time", within 5 days of the screen failure.



Reminders, Updates & Tips

- ◆ If your patient requires a "research" CTP, you must first consent the patient prior to completing the test.
- ◆ After randomizing a participant, please input the data, including con-meds and uploading the imaging as soon as possible.
- ◆ There are many "people" documents expiring. Please update them immediately as the expired certification may affect your screening and enrollment.
- ◆ Remember that the toolbox has tools that are very useful for the study, such as checklists for participant visits, checklist for the pharmacy team, all current study manuals and more!
- ◆ Please make every effort to keep the study timepoints within the window dictated in the protocol.

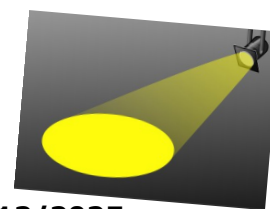

RAPID AI Completion of Installation

Please remember to continue to work through the RAPID AI process with the RAPID AI Team. This is mandatory for trial participation. Using RAPID AI may also lead to more eligible patients.

After you are released to enroll, you can continue to use your current software until the installation has been completed. The expectation is that you complete installation within 3 months of site release. Non-responsiveness to installation requests & progress will trigger a call with the National PIs.
