**A few lovely words from her PI, Dr. Schnakers:**

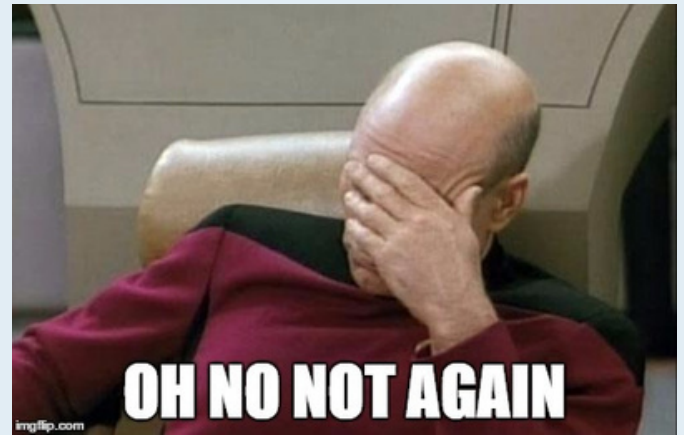

## Extra 1k payments

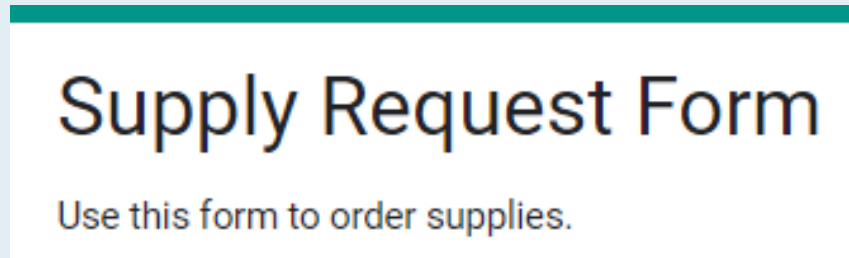

# New ordering form

We have moved from ordering supplies in KOEO to Google Sheets.

The new ordering form is user-friendly and easy to navigate. It also includes the Evora Full Face Mask and the N30i Nasal mask, replacing the F20 and N20 masks, and separates the S10 and S11 devices and supplies. # Mask Guidance

As a reminder, there is no recall related to the ResMed magnet-containing masks including the N20 and F20. Nonetheless, to avoid future concerns about magnet-containing masks, and to simplify mask selection procedures, we have decided to phase out all magnet-containing masks at sites.

Please continue to use your current supply of ResMed masks (P10, N20, and F20), using the current mask selection protocols, and referencing the safety considerations in the mask MOPs. When you need replacements for the N20 and F20 masks, magnet-free masks will be provided. To summarize the replacement plan, this is what you will receive when you re-order specific masks:

## Order this:

- P10
- N20
- F20

## Receive this:

- P10 (this is already magnet-free)
- ResMed Airfit N30i
- Fisher & Paykel Evora full face mask



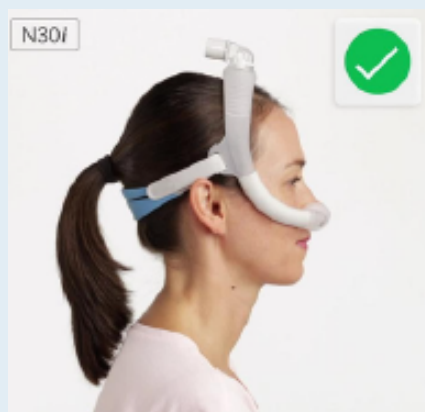
P10 Nasal pillows
